

QUIT CLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Nine and 55/100 Dollars to W. L.Wilson and wife M. E.Wilson in handpaid by Mrs. Lillie May Davis and husband Joseph B.Davis the receipt whereof is hereby acknowledged we do remise, release, quit claim and convey to the said Mrs. Lillie MayDavis & Joseph B.Davis all our right, title, interest and claim in or to the following described real estate, to-wit:

A part of NW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Sec. 34, T. 20, R. 3 west, commence at NE corner of said 40 acres, thence south 225 yds, thence west parallel with north boundary of said forty acres 140 yds, thence north parallel with east boundary line 225 yds, to north boundary line of said forty, thence east 140 yds to point of beginning containing 6 $\frac{1}{2}$ acres more or less in NE corner of said 40 acres.

Also a part of NW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Sec. 34, T. 20, R. 3 west, commence at said NE corner of said forty acres and run west 140 yds to point of commencement, thence run west 307 yds to N.W. corner of said forty acres, thence south along Section line 130 yds, thence south (73° east) 330 yds, to the S.west corner of a 7 yds strip south o f the Seagle land, thence north along the west side of said Seagle land 232 yds to point of beginning containing 11 $\frac{1}{2}$ acres more or less, also a strip of land 7 yds wide along the south end of said Seagle land, situated inShelby County, Alabama.
