KNOW ALL MEN BY THESE PRESENTS that for and in consideration of One Dollar to the undersigned grantors J.W. Naish and his wife Ella Naish, in hand paid by William Harrison the receipt whereof is hereby acknowledged, and for the further consideration and purpose of correcting a misdescription contained in a deed executed by the grantors above named to the grantse hereinabove named on the 28th day of December, 1928, said deed being recorded in the Probate Office of Shelby County Alabama, in Deed Record Volume 75 on page 170, and also to correct a description contained in that certain deed executed by the said above named grantors to the above named grantee on the 23rd day of January, 1929, said deed being recorded in the Probate Office of Shelby County, Alabama, in Deed Record Volume 84 on page 110, that the said J.W.Naish and his wife Ella Naish do grant, bargain, sell and convey unto the said William Harrison the following described real estate to-wit:
