

QUIT CLAIM DEED

KNOW ALL MEN BY THESE PRESENTS that in consideration of the sum of One Thousand Dollars to W. L. Farley and his wife Daisy Farley in hand paid by M.A.Farley the receipt whereof is hereby acknowledged we do remise, release, quit claim and convey to the said M. A.Farley all our right, title, interest and claim in or to the following described real estate to-wit:

Beginning 200 feet south of southwest corner of SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 28, Township 18, Range 1 west, thence south 69 degrees and 15 minutes east 1438 feet to the west boundary of NE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 28, Township 18, Range 1 west, thence due north along said line 1428 feet, thence north 70 degrees and 40 minutes west 990 feet to creek, thence south 12 deg. and 30 min. west 107 feet, thence south 31 deg. and 30 min. west 266 feet, thence south 24 deg. west 270 feet, thence north 68 deg. west 1012 feet, thence north 21 deg. and 30 min. east 170 feet, thence north 65 deg. and 30 min. west 570 feet, thence south 939 feet, thence south 59 deg. and 15 min. east 1438 feet to the point of beginning, containing 63.26 acres; also W $\frac{1}{2}$ of NE $\frac{1}{4}$ of Section 29, Township 18, Range 1 west, containing 80 acres and in the aggregate containing 143.26 acres.
