

Beginning at the SE corner of SW $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 34, Township 19, Range 1 West,
 Shelby County, thence N. 2 $\frac{1}{2}$ degrees, W 581 yards to A. B. & C. R. R. CO's R/W; thence
 south 80 degrees, west 100 feet; thence south 25 degrees, West 100 yards; thence south
 75 degrees west 200 feet to old livery stable barn; thence south 70 degrees west 100
 feet to Chelsea & Columbiana Road; thence south 10 degrees west long east side of said
 road 100 yards to point; thence south 30 degrees west 100 feet; thence south 2 $\frac{1}{2}$ degrees
 East 400 feet to point; thence south 45 degrees East 440 feet to East line of SW $\frac{1}{4}$ of
