KNOW ALL MEN BY THESE PRESENTS, That ~~XXXXXX/100XXXX~~ We Mrs Pearl Davidson and Husband S.P. Davidson for and in consideration of Seventeen & 50/100 \$17.50 DOLLARS, to me paid in hand by W.H. Kirkley the receipt whereof is hereby acknowledged, do grant, bargain, sell, and convey unto the said W.H. Kirkley the following described property—to wit:

Lying South of W.H. Kirkley Mill lot, and joining said Mill Lot, on the North, and the W.H. Kirkley lot on the West and Pearl Davidson Land on the South and the Baptist Church lot on the East, being a part of North-west quarter of the S.W. 1/4 of Except West 1/2 of N E 1/4 of S W 1/4 Sect (4) Township (22) South R. (3) West the above described land known as the Ozley Place. containing 7/8 of an acre beginning at the South West corner of W.H. Kirkley Mill Lot. Running South 245 yds-thence East 17 1/2 yds-thence North 245 yds-thence West 17 1/2 yds-to point of beginning
