

DEED OF GIFT

KNOW ALL MEN BY THESE PRESENTS:

That we, Victoria Nolen, Laura Nolen and Mary Nolen, each of whom is unmarried and over the age of twenty-one years, and Charles Nolen, who are the only surviving next of kin to Martha A. Nolen, deceased, late of said county and State, for and in consideration of the love and affection we bear to our beloved neice and daughter, respectively, Martha Bell Lee, and for the further consideration of the sum of one dollar to us in hand paid by said Martha Ball Lee, the receipt whereof is hereby acknowledged, have given granted and do, hereby give, grant, enfeoff and convey to said Martha Bell Lee, the following described lot or parcel of land lying and being in said county and State, to-wit:

Two acres of land lying adjacent to the southerly boundary of the State Highway, otherwise known as the Montevallo and Centerville Public Road, on the North and to the west line of the northeast quarter of the southwest quarter of section seventeen (17), Township twenty-four (24) N. Range twelve (12) East on the west, and which two acres is more particularly described as follows, to-wit: Beginning at a point of intersection of the said south boundary line of said highway with the west line of said Northeast quarter of south-west quarter, running thence south along the said alast mentioned a distance of four hundred twenty (420) feet; thence eastwardly, parallel with said Highway, a distance of two hundred ten (210) feet; thence northwardly four hundred twenty (420) feet, to a point on the southerly boundary of said Highway which is two hundred ten (210) feet eastwardly from said point of beginning and thence westwardly, along said boundary line of said Highway, to the point of beginning; being the lot on which the husband of said Martha Bell Lee has erected a dwelling and other improvements and on which they now reside.
