

TRANSFER

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of One Hundred (\$100.00) Dollars and other valuable considerations, cash in hand paid by Emma Granger Lett to the undersigned Mabel R. Glass, the receipt of which is hereby acknowledged, I, the undersigned Mabel R. Glass, do hereby sell, assign, transfer and deliver to the said Emma Granger Lett the following described mortgages owned by me, to-wit:

1. That certain mortgage executed to me by Elizabeth A. Howard on September 6, 1928, and recorded in Volume 152, Record of Mortgages, Page 506, in the office of the Probate Judge of Shelby County, Alabama, on which mortgage there is now due the sum of Two Hundred (\$200.00) Dollars with interest at 8% from September 20, 1930, and there is also due, as provided in said mortgage, an attorney's fee to my attorney Harris Burns in whose hands I placed said mortgage for collection or foreclosure, and there is also due on same taxes on the property therein described, which I have paid, amounting to \$10.27.

2. Also that certain mortgage executed to me by John William Howard on September 24, 1930, and recorded in Volume 160, Record of Mortgages, Page 495, in the office of the Probate Judge of Shelby County, Alabama, on which there is due the sum of One Hundred (\$100.00) Dollars with interest at 8% from September 24, 1930, and on which there is also due an attorney's fee to my attorney, Harris Burns, in whose hands I placed said mortgage for collection or foreclosure.

And for the consideration above mentioned I do also sell, assign, transfer and deliver to the said Emma Granger Lett the notes mentioned in and secured by said mortgages above described and do also remise, release, quit claim and convey unto the said Emma Granger Lett all of my right, title, interest, and claim in and to the property described in said mortgages which is as follows, to-wit:

The SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ and the NW diagonal half of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, said diagonal half of said quarter quarter section being described as follows: Commence at the SE corner of said SW $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 7, Tp. 19, Range 1 West; thence running NW to the NW corner of said forty acres; thence East to the NE corner of said forty acres; thence South to the point of beginning, all of said land being situated in Section 7, Tp. 19, Range 1 West, Shelby County, Alabama, and containing 60 acres.

TO HAVE AND TO HOLD unto the said Emma Granger Lett, her heirs and assigns forever. It is understood that this mortgage and the indebtedness thereby secured is transferred without recourse on me.
