AGREFMENT between C.S.Bissell and his wife Castella V.W. Bissell; parties of the first part, herein referred to as "Grantors", and Adele G. McNeel, party of the second part, herein referred to as "Grantee";

RECITALS

The said C.S.Bissell owns the Southwest diagonal half of the Southwest Quarter of the Southeast Quarter of Section 19, in Township 18 South, Range 1 West in Shelby County, Alabama, excepting the minerals located thereon and therein, and the said Adele G. McNeel owns the Northeast diagonal half of the said quarter-quarter section, excepting the minerals therein and thereon. A fresh water spring is, or fresh water wprings are, located on the said quarter-quarter section near the northwest corner thereof on or near the dividing line between the respective parts of the said quarter-quarter section owned by the parties as aforesaid.

that in the event any of the said springs are located on the Southwest diagonal half of the said quarter-quarter section that the Grantce and her heirs and assigns Shall at all times hereafter have the right to use the same and take water therefrom for use on the North-east diagonal half of the said quarter-quarter section.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) paid to Grantors by Grantee, the receipt whereof is hereby acknowledged, Grantors do hereby remise, release, quit-claim and convey unto Grantee the right privilege, and easement of using such spring or springs which may be located on the Southwest diagonal half of the said quarter-quarter acction and of taking water therefrom for use on the North-east diagonal half of the said quarter-quarter section, together with the right of ingress and egress over and upon the said Southwest diagonal half of the said quarter-quarter section between the said spring or springs and the said Northeast diagonal half of the said quarter-quarter section.

TO HAVE AND TO HOLD the aforegranted rights, privileges, and easements unto the Grantee, her heirs and assigns, forever.

Nothing herein contained, however, shall constitute a representation by the Grantors that any such spring or Eprings are located on the Northwest diagonal half of the quarter-quarter section herein described.
