I (we) further agree that the deposit made by me (us) in connection with this transaction, may be applied for reimbursement for any expense and/or loss incurred by General Motors Acceptance Corporation, in the event of breach of this trust or repossession of said motor vehicles. It is further agreed that no one has authority to vary the terms of this trust receipt.
