deed and had tenants upon it, living on it and cultivating it each and every year until said Weldon deeded it to Boyd W. Beason, also known as B.W. Beason, by deed dated September 30, 1915, and recorded in the Probate Office of Shelby County, Alabama, in deed book 79 at page 162; said Boyd W. Beason immediately upon the execution of the last mentioned deed moved upon said land, lived upon it and cultivated it continuously until he deeded it to W.H.Clark by deed dated July 11, 1919, and recorded in the Probate Office of Shelby County, Alabama, in deed book 66 at page 454; immediately upon the execution of the last mentioned deed said W.H.Clark went in possession of said land, moved upon it and lived upon it and cultivated in each and every year until he deeded it to Emma Brodie, on the 19th day of July, 1926, by deed which is recorded in the Probate Office of Shelby County, Alabama, in deed book 79 at page 165; immediately upon the execution of the last mentioned dedd said Emma Brodie went in possession of said land and had it occupied by tenants who lived upon it, and cultivated it each and every year until she deeded.
