ITEM 3.

I appoint my said brother, Herman Rich, as executors of this my will and exempt him from giving any bond as such. I also exempt him from filing any inventory of my estate or from making any reporteto any court, I give him as executor full power and authority to sell, at public or private sale and without orders of any court, any part of all of my property for any purpose that he may deed best.
