DECREE ON PETITION OF GEORGE W. COURSON AND J. WILEY LOGAN TO HAVE RECEIVER OF
BANKERS MORTGAGE BOND COMPANY CANCEL THE MORTGAGES SET OUT IN SAID PETITION.

This matter coming on to be heard on the petition of George W. Courson and J. Wiley Logan, to have the Receiver of Bankers Mortgage Bond Company, cancel and satisfy of record the mortgage executed by Mrs. Willena Courson and George W. Courson on Lot 10 in Block 8, survey of R.W.Owens Addition to Birmingham, called Owenton, said mortgage being recorded in Volume 876 at page 234, Records of Mortgages in the office of the Judge of Probate of Jefferson County, Alabama, and also to have said Receiver to cancel and satisfy of record the mortgage executed by Ford Brothers Realty and Insurance Company to Bankers Mortgage Bond Company on and against the real property in Shelby County, Alabama, described as the W $\frac{1}{2}$, except 53 acres more or less thereof, located in Jefferson County; the N $\frac{1}{2}$ of the NE $\frac{1}{4}$; the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 13, Township 18, Range 1 West, minerals and mining rights excepted, said mortgage being recorded in Volume 121 at page 623, records of mortgages in the office of the Judge of Probate of Shelby County Alabama.

And it ~~is~~ further appearing to the court that the petitioners are entitled to the relief prayed for; it is therefore ordered, adjudged and decreed by the Court that Harold Harper, as Receiver of said Bankers Mortgage Bond Company is hereby authorized and directed to enter upon the margin of the record of said mortgage on lot 10 in Block 8, in the survey of Owenton, recorded in Volume 876 at page 234, records of Mortgages in the office of the Judge of Probate Jefferson County, Alabama, the cancellation and satisfaction of said mortgage, and it is further ordered, adjudged and decreed that W.J.Horseley, as the agent or Attorney in Fact of Harold Harper, as Receiver of Bankers Mortgage Bond Company, is hereby authorized and directed to enter upon the margin of the record of mortgage on said lands in Shelby County, Alabama, said mortgage being recorded in Volume 121 at page 623, records of mortgages in the office of the Judge of Probate of Shelby County, Alabama, the cancellation and satisfaction of said mortgages.
