

## Right of way deed for public road

State of Alabama,  
Shelby County)

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, P. C. Wilson  
An Unmarried Man of the County and State aforesaid, in and for the consideration of one dollar  
\$175.00 in hand paid by Shelby County, Alabama, a corporation, the receipt whereof is hereby  
acknowledged and for the further consideration of the benefit accruing to us and to the public  
from the construction or improvements of a public road through our lands, in Shelby County,  
do hereby give, grant, bargain, sell and convey unto Shelby County, Alabama, a corporation,  
its successors or assigns, a Right-Of Way hereinafter described, over and across our said lands  
in Shelby County, Ala., for a public road; Which right-of-way shall be --- feet in width on--  
side on the center line of said road, as it is now located and staked out by the State High-  
way Department, or as much of our lands as is required to make a --foot right-of-way across our  
lands, said right-of-way herein conveyed being more particularly described as follows, to-wit:

A strip of land lying along the right and the left side of the center line  
of highway known as NRM-360(1935) as now located and staked out by the State Highway Department,  
and more particularly described as follows:

Beginning at station 27/42 turn an angle of 127° to the left and run in a northerly direction  
65 feet, thence turn an angle to the right and run in an easterly direction along a curve to the  
left whose radius is 1860.8 feet, parallel to and 50 feet from said center line a distance of  
668.5 feet, thence turn 90° right and run 50 feet to center of present Calera-Montevallo Highway,  
thence turn 90° right and run along center line of said present Calera-Montevallo Highway in  
a westerly direction 625 feet to the east property line of J.T. Doster. Thence turn 75°  
right and run along said property line in a northwesterly direction a distance of 125 feet to  
point of beginning.

All of the herein described property lying and being within the incorporated  
limits of the City of Montevallo, Shelby County, Alabama, and containing 1.3464 acres, more or  
less, part of which is the present traveled way.

To have and to hold by Shelby County, or its assigns, and for and in consideration of  
the benefit to our property by reason of the construction or improvement of said road,  
we hereby release the County aforesaid, and all of its employees and officers, and the State of  
Alabama and all of its employees and officers from all consequential damages, present or prospective  
to our property, arising out of the construction, improvements, maintenance or repair of said  
road, and that said road is a benefit to our property is hereby admitted and acknowledged.
