Whereas, a road or street, heretofore known as Spencer house Street, leading to and intersecting with East College Street, passed through the hereinafter described tract of land in the Town of Columbiana, Alabama, to-wit:

A certain lot or parcel of land situated in Columbiana, Shelby County, Alabama, being a part of the East Half of Morthwest Quarter of Section 25, Township, 21.

Range 1 West, and more particularly described as follows:

Beginning at a point where the street connecting Whate Street and East College Street intersects East College Street, and running South along said street 235 feet, thence East 100 feet, thence North 235 feet to East College Street, thence West along East College Street 72 feet to the point of beginning. Situated in Shelby County, Alabama.

And, Whereas, more than thirty years last part, said road or street, on, along or across said above described lot was changed, and such changed street is now known and designated as Chatherine Street in the Town of Columbiana, Alabama, extending from Whate or Mildred Street to East College Street; and

Whereas, such vacating or change in location when made was assented to, acquiesced in or authorized by the Municipal authorities of the Town of Columbiana, or which has been heretofore ratified or confirmed by such municipal authority; and

Whereas, such change has been validated, ratified and confirmed and all the rights or title of the public in such road, street, avenue or alley or part thereof sobbacated or attempted to be vacated, including all rights acquired by perscription, are relinquished and abandoned; and

Whereas, it is shown to the satisfaction of the Mayor and the Council of the Town of Columbiana, Alabama, that all interest of the public and of said Town has been surrendered, as aforesaid; and that the present owner and party in possession, Inez Jordan Bird, and her predecessors in title have been in the open, nototious, continuous, peaceful and adverse possession of said abandoned roadway for more than thirty years;

Therefore, be it resolved by the Mayor and the Council of the Town of Columbiana, Alabama, that that portion of said abandoned roadway that runs along or across the above described lot be conveyed by quitclaim deed by the Town of Columbiana, Alabama to the said Inez Jordan Bird, and that the Mayor be authorized, and is hereby empowered to convey by quitclaim deed all right, interest and title which is held by the Town of Columbiana, Alabama, to said abandoned roadway.
