KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, on 12th day of September, A. D. 1932, the Probate Court of Shelby County rendered a decree for the sale of lands hereinafter described and conveyed, for the payment of State and County taxes then due from Lula Belle Morrow, the owner of said lands, and for the payment of the fees, costs, and expenses of and under said decree, and the sale had in execution thereof.

AND WHEREAS, thereafter, to-wit, on the 17th day of October, 1932, under and in pursuance of said decree, said lands were regularly offered for sale by the Tax Collector of Shelby County for said taxes, fees, costs, and expenses, and no person having bid a sufficient sum for said lands to pay the same, said lands were bid in for the State for the sum of said taxes, fees, costs, and expenses.

AND WHEREAS, the time allowed by law for the redemption of said lands has elapsed since said sale, and the same not having been redeemed, the title thereto under said sale is still in the State.

AND WHEREAS, said lands having been entered upon the books of the State Land Commissioner, and the State Land Commissioner of the State of Alabama, with the approval of the Governor, has fixed the price of said land, and ascertained that the sum of Fifty-one and 75/100 (\$51.75)----Dollars is sufficient to cover and satisfy all claims of the State and County against said lands for or on account of taxes, interest, fees, and costs, and officers fees which were due upon or have accrued against said lands, as provided for by law.

AND WHEREAS, application has been made to the State Land Commissioner of the State of Alabama by C. O. Chambless to purchase said lands, and said sum of Fifty-one and 75/100 (\$51.75) dollars therefor has been paid into the State Treasury.

NOW, THEREFORE, The State Land Commissioner of the State of Alabama, by virtue of and in accordance with the authoraty in him vested by law, with the approval of the Governor of Alabama, and in consideration of the premises above set out, has this day granted, bargained sold, and conveyed, and by these presents does grant, bargain, sell, and convey unto the said C. O. Chambless, without warranty or covenant of any kind on the part of the State, express or implied, all right and title of the State of Alabama in and to said lands, described as follows:
