AND WHEREAS, application has been made to the State Land Commissionner of the State of Alabama by C. O. Chambless to purchase said lands, and said sum of Three Hundred Eighteen and 09/100 (\$318.09) Dollars therefor has been paid into the State Treasury.

NOW THEREFORE, the State Land Commissioner of the State of Alabama, by virtue of and in accordance with the authority in him vested by law, with the approval of the Governor of Alabama, and in consideration of the premises above set out, has this day granted, bargainsd, sold, and conveyed, and by these presents does grant, bargain, sell, and convey unto the said C. O. Chambless without warranty of covenant of any kind on the part of the State, express or implied, all right and title of the State of Alabama in and to said lands, described as follows:
