

Right of way deed for public road

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned Holcombe Mercantile Co., a corporation, of the County and State aforesaid, in and for the consideration of One dollar (\$1.00) in hand paid by Shelby County, a corporation, the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto said Shelby County, its successors or assigns, a right-of-way hereinafter described, over and across our said lands in Shelby County, Ala., for a public road; which right of way shall be 50 feet in width on east side of the center line of said road, as it is now staked out by the State Highway Department, or as much of our lands as is required to make a 50 foot right of way across our lands, said right of way herein conveyed being more particularly described as follows, to-wit:

a strip of land 50 feet wide lying on east side and parallel to the center line of Federal Aid Project # 99, as now staked out by the State Highway Department of Alabama, beginning at station 0+00 and ending at station 6+45.

also a strip of land 50 feet wide lying on the east side and parallel to the center line of Federal Aid Project # 99, as now staked out by the State Highway Department of Alabama, beginning at station 9+45 and ending at station 11+45.

All of the above described land being in the SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 11, Township 24N, Range 13E, in Shelby County, Alabama.

TO HAVE AND TO HOLD, by Shelby County, or its Assigns, and for and in consideration of the benefit to our property by reason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees, and officers, and the State of Alabama, and all of its employees and officers from all consequential damages, present, or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged.
