

Right-of Way Deed for Public Road

STATE OF ALABAMA, )

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, Tom Wallace and wife Martha Wallace of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County, a corporation the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, A corporation, its successors or assigns, a Right-of-Way herein after described, over and across our said lands in Shelby County, Ala., for a public road; Which right-of-way shall be Fifty feet in width on each side of the center line of said road, as it is now located and staked out by the State Highway Department, or as much of our lands as is required to make a 100 foot right-of-way across our lands, said right of way herein conveyed being more particularly described as follows, to-wit:

A strip of land 100 feet wide lying 50 feet each side of and parallel to the center line of Federal Aid Project #99m as now staked out by the State Highway Department of Alabama, beginning at station 255/41 and ending at station 260/30.

All of the above described land being in the NW $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 9, Township 22S, Range 2W in Shelby County, Alabama.

To Have and To Hold by Shelby County, or its Assigns, and for and in consideration of the benefit to our property by reason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees and officers, and the State of Alabama and all of its employees and officers from all consequential damages, present or prospective to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged.
