Four acres more or less in the Northeast quarter of the Southeast quarter of Section 1- Township 21, Range 1 East.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof including the right of ingress and egress to and from said lines; and also to cut and keep clear all trees, and to keep clear other obstructions that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.
