Three acres more or less in the NE1 of NE1 Sec. 3 Township 22 Range 4 West, Beginning to point on the North margin of Montevallo & Tuscaloosa road at point 347 feet east of intersection of said road west to west boundary of NE1 of NE1 thence run North 210 feet, thence West 210 thence North 500 feet more or less to the North line of said Section, thence east along said section line 310 feet to a point, thence south 980 feet more or less to the morth margin of Montevallo and Tuscaloosa Road, thence West 200 feet to point of beginning in the West 1 of the NE1 of NE1 Sec. 3, Township 22 Range 4 West.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines;
and also the right to cut and keep clear all trees, and to keep clear other obstructions,
that may injure or endanger said lines.
