Whitfield, the following described real estate, to-wit:

All that part of the North-west quarter of the North-west quarter of Section 8 lying Southeast of the right of way of the Saginaw Lumber Company's logging railroad, containing 20 acres more or less.

Also the South-west quarter of the North-west quarter, less a strip 35 feet wide for a right of way; also the Northwest quarter of the Southwest quarter of Section 8, less a strip containing two acres in the South part of said 40 acres;
