

Copy of Will

State of Alabama,

I, W. T. Hill, a resident of Birmingham, Jefferson County, Alabama, over the age of twenty-one years, and being of sound mind, and disposing memory, and realizing the uncertainty of life, and desiring to dispose of my worldly goods as hereinafter provided, do hereby make and publish, this my last will and testament, revoking any and all former wills, which may have heretofore been made by me.
First. I will that all my debts and funeral expenses shall be paid by my executrix, hereinafter named, as soon after my deceased as practical.

Second. I give, will, devise and bequeath to my wife, Lalla Rookh Harris Hill, and to my daughter Lalla Rookh Hill, share and share alike, all the property of every kind real, personal and mixed of which I shall die seized and possessed or to which I may be entitled at the time of my deceased for them to take, have and to hold the same, in fee simple, forever.

Third. I nominate and appoint my wife, Lalla Rookh Harris Hill as executrix of this my last will and testament, and do hereby expressly exempt her from giving any bond for the performance of her duties arising thereunder. And if in the course of handling the estate, my said executrix should find it desirable and advantageous to sell any part of the real estate, or personal property devised under this will, she is hereby expressly authorized to make such conveyance, without any order of the Court therefor, provided that one-half of the purchase price of the said property shall be deposited in The Birmingham Trust & Savings Company, of Birmingham, Alabama, to the credit of my daughter, Lalla Rookh Hill, and for her use and benefit.
