KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of One Dollar, in hand paid to the undersigned grantor, Columbiana Savings Bank, a corporation, by W.H.Templin, the receipt whereof is hereby acknowledged, the said Columbiana Savings Bank, does hereby release and discharge from that certain lien created by that certain judgment wherein the Columbiana Savings Bank, a corporation, was plaintiff, and W. B. White, W.H. Templin and L. B. Crumpton were defendants, which said judgment was rendered in the Circuit Court of Shelby County, Alabama, on May 12th, 1936, for the sum of \$255.95, and which said judgment is recorded in the Probate Office of Shelby County, Alabama, in Judgment record D on page 139, the following described real estate situated in Shelby County, Alabama, to-wit:
