
KNOW ALL MEN BY THESE PRESENTS, That For and in consideration of Sixty and no/100 dollars to the undersigned grantor, Mrs H.L. Johnson, DOLLARS, paid in hand by Fred Johnson, the receipt whereof is hereby acknowledged, I the said Mrs H.L. Johnson do grant, bargain, sell, and convey unto tht said Fred Johnson the following described property—to wit:

Beginning at Longview road where it intersects Montevallo Road running South along Montevallo Road (231) ft thence East one 1/4 mile thence North 231 ft., to Longview Road thence West along Longview Road to point of beg in Section 35, Township 21, Range 3 West

situated, lying and being in the County of Shelby and State of Alabama. TO HAVE AND TO HOLD the same unto the said Fred Johnson and wife Willie K Johnson heirs and assigns, forever. And I do, for my and heirs, executors, and administrators, covenant with the said Fred Johnson and wife Willie K Johnson heirs and assigns, that I lawfully seized in fee-simple of said premises; that they are free from all incumbrances; that I have a good right to sell and convey the said property; that I will, and my heirs, executors, and administrators shall warrant and defend the same to said Fred Johnson and wife, heirs, executors, and assigns, forever, against the lawful claims of all persons whomsoever.
