I, Jabez Page, of 700, Mitchell Avenue, Pratt City, Birmingham Alabama, being of sound mind and disposing memory, do hereby make and publish this, my last will and testament, hereby revoking all former wills and testaments by me made.

FIRST: That all my funeral expenses and debts be paid.

Second: I hereby give, devise and bequeath to my wife, Maggie Page, all my lands, tenements, and hereditaments, and all my household furniture, ready money, securities for money, money secured by goods and chattels and all other parts of my real and personal estate and effects whatsoever and wheresoever located, for her absolute use and benefit, according to the nature and quality thereof respectively during her lifetime and at her death the above described real and personal estate and effects are to be divided equally among my three daughters, Mrs. Sarah Page Marden, Lottie Page and Rose Page, I hereby give my wife the right and privilege to sell or dispose of any or all of the above described real or personal property estate or borrow money on same,

I hereby appoint my two daughters, Lottie Page and Rosa Page, Executrices of this my last will and testament, and shall be released from giving any bond whatsoever for the proper performance of their duties hereunder.
