Siniard and wife, Edna Siniard, parties of the first part, hereinafter called the Lessors, do grant bargain, sell and convey unto Alabama Cooperage Company, Inc., party of the second part, hereinafter known as the Lessee, all pine timber 8 inches or more in diameter 12 inches from the ground on the following described land:

> Southeast quarter of the northeast quarter of Section 22, Township 21, Range 2 West, Shelby County, Alabama.

This lease, however, shall be subject to the following conditions;

- 1. That Alabama Cooperage Company, Inc., agrees to pay the lessors the sum of One Dollar a cord for said timber, which is to be paid for once a week, every Saturday, and the parties hereto agree that said Lessee may pay Mrs. J. B. Hill for all of said timber who is authorized to accept said payment and release Lessee from any liability to pay any of the other of said Lessors, and her acceptance of said payments shall be considered a release of the Lessee. Provided further that there shall be no obligation on the Lessee to cut and remove all or any part of said timber, but Lessee may determine this lease at any time by giving 10 days notice to the Lessors, without liability on its part.
- 2. That Alabama Cooperage Company, Inc., shall have one year from the date the last person signs this instrument to cut and remove said timber, and after that time shall have no further rights or interest in said land or timber.

It is further understood and agreed that the lessee shall have the right of egress and ingress over any land owned by lessors, adjoining the above said land, if it will expedite the cutting and removing of the above said timber.

And in connection with all of the above described land, and above mentioned land, the Lessee shall use all reasonable care to prevent any part of said lands from being burned over, and shall do no unnecessary damage to timber on said lands not herein conveyed.
