Before me C. V. Moore, a Notary Public in and for said County, in said State, personally appeared C. B. Naish, who is known to me and who, being by me first duly sworn, depōses and says:

I am acquainted with the following described tract of land situated in Shelby County, Alabama, viz:

Begin at the north west corner of Section 17, Township 21, Range 2 West, and run thence south along road, south 2 degrees 30 minutes east 1209 feet to a point of beginning of the tract of land herein described, thence continue along said road south 2 degrees 30 minutes east 1214 feet to the north west corner of the cemetery lot, thence south 87 degrees 45 minutes east 467.5 feet, thence south 8 degrees 10 minutes east 180.5 feet, thence north 87 degrees 45 minutes west 467.5 feet to the south west corner of the cemetery lot, thence south 2 degrees 30 minutes east 20.8 feet to the south west corner of the north west quarter of said section 17, thence south 87 degrees 28 minutes east 2648 feet, thence north 2 degrees 30 minutes west 1018.5 feet, to old Columbiana Road, thence north 69 degrees 54 minutes west 317 feet, thence north 44 degrees 30 minutes west 139.4 feet, thence north 62 degrees 30 minutes west 373.2 feet, thence north 83 degrees 15 minutes west 157.7 feet, thence north 88 degrees 45 minutes west 315.8 feet, thence south 82 degrees 45 minutes west 483.7 feet, thence south 79 degrees 30 minutes west 326.4 feet, thence north 2 degrees 30 minutes west 301 feet, thence south 83 degrees 30 minutes west 643 feet to the point of the tract of land herein described, and containing 75.8 acres, more or less.

I have known this land practically all my life, I knew it before the present owner Mr. J. R. Nabors, went in possession of it under deed from his father, Mr. John W. Nabors

J. R. Nabors has been in possession of the aforementioned land under deed from his father, J. W. Nabors, on the 1st day of August, 1904, by deed which is recorded in the Probate Office of Shelby County, Alabama, in deed book 35 at page 552, ever since he obtained said deed. He went in possession of said land immediately after the execution of the aforementioned deed and lived upon it continuously until 1918, during which time he cultivated portions of it each and every year, and since that time he has been in the actual, open, notorious, continuous, exclusive, adverse, possession of said land by having tenants upon it, actually living upon it and cultivating portions of it each and every year down to the present time.
