

QUIT CLAIM DEED TO CURE TITLE

Gilbert and wife, Callie Gilbert the receipt whereof is hereby acknowledged, do hereby remise, release, quitclaim and convey unto the said W. L. Gilbert and Callie Gilbert all my right, title, interest and claim in and to the following described real estate situate in the County of Shelby, State of Alabama, to-wit:

Begin at the north west corner of Section 17, Township 21, Range 2 West, thence run along road, south 2 degrees 30 minutes east 1209 feet, thence north 83 degrees 30 minutes east 643 feet, thence south 2 degrees 30 minutes east 301 feet, thence north 79 degrees 30 minutes east 326.4 feet, thence north 82 degrees 45 minutes east to the eastern line of the south west quarter of the north west quarter of said section 17, thence north along said forty line to the south east corner of the north west quarter of the north west quarter, thence along the eastern boundary line of said last named forty to the north east corner thereof, thence west along the north line of said forty to the point of beginning, EXCEPT that part thereof which belongs to and is owned by J.
