Ed Jones, a widower, for and in consideration of the sum of One Dollar (\$1.00) to me in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon over and across the following described lands situated in Shelby County, Alabama:

Four (4) acres, more or less in NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 36, T $\frac{1}{2}$ 19 R 3 W described as follows: Begin at an iron stake at SW corner of NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Said Section 36, run thence East along 40 acre line 2 chains 60 links to NW side of Helena-Acton Road, thence NE along NW margin of road 6 chains 7 links to iron stake thence NW 11 chains 30 links to West side of branch, thence SW along south side of branch 70 links to North and South 40 acre line, thence due South along 40 acre line 12 chains 50 links to SW corner of said 40 acres to point of beginning.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.
