Bailey appearing not, a decree pro confesso was granted; That upon the submission of the original bill of complaint with decree pro confesso, as noted by the Register, a sale for division by the Register of the proceeding after all costs and expenses, and a reasonable Solicitor's fee to Wm. G. Dooly Sr. have Birst been paid, of the following real estate was ordered and decreed by this fourt, to-wit:
