 paid in hand by C.R. Knowles, the receipt whereof is hereby acknowledged, we the
 said Louise R. Jones, and Walter Jones, do grant, bargain, sell, and convey unto the said C.R. Knowles
 the following described property—to wit:

A part of the east half of the south west quarter of Section 23, Township 22,
 Range 3 west, described as follows: Begin at the north west corner of the north east quarter
 of the south west quarter of said Section, Township and Range, thence south 2 degrees 40
 minutes east 1464.5 feet, to the right of way of the Southern Railroad, thence along the
 north line of said right of way south 70 degrees east 753.0 feet, thence north 2 degrees 40
 minutes west 1700.0 feet, thence south 82 degrees 30 minutes west 700.0 feet to the point of
 beginning, containing 24.5 acres more or less.

Also a parcel of land described as follows: Begin at the south east corner of Fractional B Section
 1, Township 24, Range 12 East, and run thence north 73 degrees 30 minutes west 1235.0 feet
