

Helena-Irwin Jenkins Extension off Helena Substation

Parcel No. 32108 - Transmission Line Permit

WE, Carrie Lee Cummins and husband T. A. Cummins and E. T. Lee and wife Romana M. Lee for and in consideration of the sum of One and No/100 Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described land situated in Shelby County, Alabama.

That certain tract of land situated in the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 22 Township 20, Range 3 West, being bounded, as follows: north by lot of Jesse Lambert east by dirt road, and south by lot of W. I. Jenkins.

It is agreed that in the event said poles and appliances interfere with erection of any building or the construction of any roads on said property in the future, the grantee will relocate said poles and appliances on said land so they will not interfere with said buildings or roads, and consent is hereby given the grantee to so relocate said poles and appliances on said land.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD THE SAME to the said Company, its successors and assigns, forever.
