Montgomery the receipt whereof is hereby acknowledged, do hereby remise, release, quitclaim and convey unto the said Lula C. Montgomery all my right, title, interest and claim in and to the following described real estate situate in the County of Shelby, State of Alabama, to-wit:

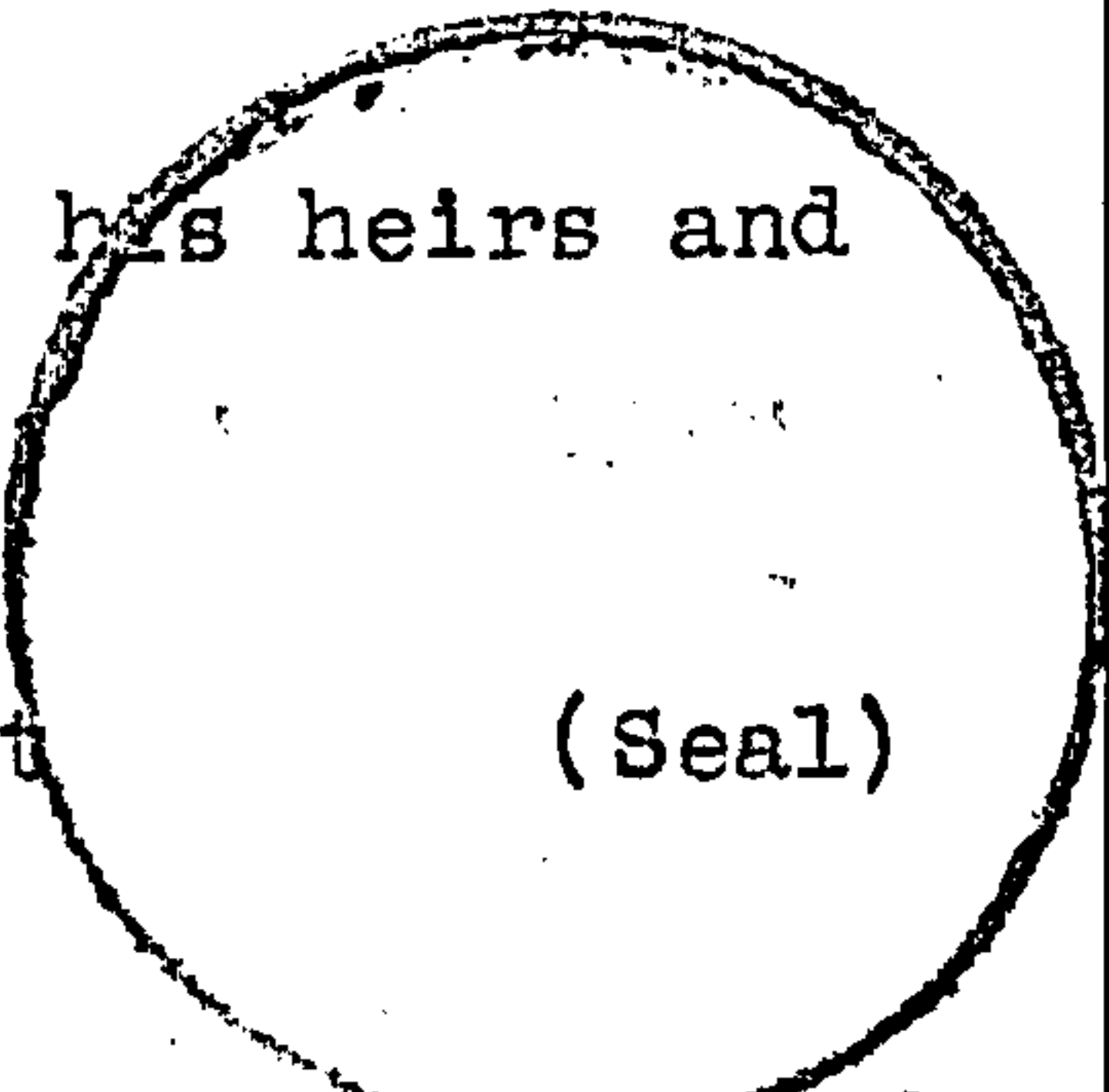
Commencing forty yards east of automatic gate on Vincent road thence south fourteen chains, thence east twenty eight chains thence north to Vincent dirt road, thence west along the Vincent dirt road, the starting point, containing twenty six acres more or less, being in section nine, township nineteen, range two east. Also the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ and 13 acres off the east side of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$, Sec. 8, Township 19, Range 2 East. Also 1/7 interest in the C. M. Elliott estate described as follows: Commencing at stake at NW corner of NW $\frac{1}{4}$ of SE $\frac{1}{4}$, thence east 23 chains to Rocky Branch, thence in South easterly direction 218 yds to LC.
