WARRANTY DEED

Know All Men By These Presents, That for and in consideration of the sum of three Hundred Dollars, in hand paid to Estelle Wallace Doty and her husband, Harold Doty by T. S. Wallace, the receipt whereof is hereby acknowledged; We the said Estelle Wallace Doty and Harold Doty do remise, release, quit claim and convey to the said T. S. Wallace all our right, title, interest and claim, in and to the Estate of Thomas L. Wallace, both personal and real; the Real Estate described as follows: to-wit:

A portion of the NW $\frac{1}{4}$  of NW $\frac{1}{4}$  Section 22 Township 20 Range 3 West, described as follows, begin at the SW corner of T. A. Johnsey's home lot and running southward about 350 feet to a ditch or drain running eastward thence southeastward along said ditch, until it diverges more to the east about 250 feet and continuing on said ditch about 375 feet to  $\frac{1}{4}$  mile section line, thence north on said line to the S. E. corner of the T. H. Griffin lot 528 feet thence westward along the south boundary of said Griffin lot, where it blends with T. A. Johnsey's S. E. corner continuing westward along the south boundary line of T. A. Johnsey's lot to point of beginning, this line being about 600 feet.

Also - a part of lot 1 in block 13 according to map of Helena by Joseph Squire, beginning at the SE corner of said lot and running west along First Avenue 176 feet to the section line between sections 15 and 16 T 20 R 3 West, thence north along said section line 195 feet to  $\frac{1}{4}$  section post, thence east parallel with First Avenue 176 feet, thence south 195 feet to point of beginning containing 3/4 acre more or less, in the NW corner of NW $\frac{1}{4}$  of SW $\frac{1}{4}$  section 15 township 20 range 3 West.
