

# DECREE & Assignment

STATE OF ALABAMA !

MONTGOMERY COUNTY !

KNOW ALL YE MEN BY THESE PRESENTS, That in consideration of the payment by Commercial Casualty Insurance Company, a Corporation, to the State of Alabama, for itself and for the use and benefit of Shelby County, Alabama, of the sum of Two Thousand Five Hundred and 00/100 Dollars (\$2,500.00), receipt of which is hereby acknowledged, the State of Alabama, acting by and through its Attorney General, hereby assigns and transfers to Commercial Casualty Insurance Company, a Corporation, all claims and demands which the State of Alabama, for itself and for the use and benefit of Shelby County, Alabama, has against Calvin T. Weldon, Ex-Circuit Clerk of Shelby County, Alabama, growing out of the examination made of the books and records of his office as Clerk of the Circuit Court of said county for the period beginning July 1, 1937, and ending July 23, 1938.

Said sum of Two Thousand Five Hundred and 00/100 Dollars (\$2,500.00) is paid to the State of Alabama, by the above named party in full settlement of all claims against said party as surety on the official bond of Calvin T. Weldon, as Clerk of the Circuit Court of Shelby County, Alabama, for the period of his term of office as above set forth, growing out of the said aforementioned examination. It is the purpose and intent of this instrument to subrogate to Commercial Casualty Insurance Company, a Corporation, all the rights which the State of Alabama, for itself and for the use and benefit of Shelby County, Alabama, has to recover against the said Calvin T. Weldon for the amounts charged in the aforesaid examination.

Weldon, J. C. Kidd, J. H. Thompson, E. L. Crumpton, O. P. Head (Mrs.) Gladys Weldon, Jesse Weldon, W. J. Weldon, G. E. Wldon, Minnie Weldon Story, L. B. Riddle, A. E. Norwood, Harry Gordon and Lavonia Gordon the sum of Two Thousand Five Hundred and no/100 Dollars (\$2,500.00).

ORDERED, ADJUDGED AND DECREED BY THE COURT That the State of Alabama, for itself and for the use and benefit of Shelby County, Alabama, as complainant, have and recover of the respondents Calvin T. Weldon and the Commercial Casualty Insurance Company, a Corporation, the sum of Two Thousand Five Hundred and no/100 Dollars (\$2,500.00)

Weldon.

FURTHER ORDERED, ADJUDGED AND DECREED BY THE COURT That the complainant be and is hereby taxed with all costs of this cause to be paid in the manner prescribed by law.

FURTHER ORDERED, ADJUDGED AND DECREED BY THE COURT That execution issue against the respondents for the payment of the amounts set forth above.
