

TRANSMISSION LINE PERMIT

We, E. C. Acton and wife, Marie L. Acton, for and in consideration of the sum of One and no/100 Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof, is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time the electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama.

Beginning at the NE corner of Section 14 Township 21, Range 3 west and running South 106 feet to NE corner of W. C. Tuckers property; thence west 516 feet to Montevallo Road; thence in north westerly direction along east side of said road to the north boundary line of said section 14; thence East 585 feet, more or less, to point of beginning, containing 2 acres more or less, and being a portion of the Estate of J. H. Cost, deceased.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all tress, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.
