North by other lands of grantors, West by lands of wrs. Ed. Lyman and Luquire, South by land of Thomas, and East by the Montevallo-Ashville Road. Also NW4 of NE4 of Section 11, Township 22, Range 3. 11 acres in NE4 of Nw4 of Nw4 of Nw4 of Nw4 of Ne4 of Section 11, Township 22, Range 3.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear other obstructions, that may injure or endanger said lines.
