McMillan; thence 610 ft. more or less to the intersection of the South line of the NW of the SW of Section 12, Township 22S, Range 2W and the center line of the said road; the above described tract of land lying in the NET of the SW and the NW of the SW, all in Section 12, Township 22S, Range 2W, Shelby County, and containing 0.70 acres more or less. And for and in consideration of the benefit to our property by reason of the construction of said road, we hereby release the county from all consequential damages, present or prospective to our property, arising out of the construction, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged.
