A strip of 1 and 66 feet wide 35 feet on each side of center line of State Project 531-A as now staked out by the State Highway Department of Alabama. Beginning at a Station: 484-43 and ending at Station 487 40. Said strip of land lies in the SW of the NW4 of Section 6, Township 2 South, Range 2 East, Shelby County, Alabama.

And for and in consideration of the benefit to our property by reason of the construction of said road, we hereby release the county from all consequential damages, present or prospective to our property, arising out of the construction, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged.
