

TRANSMISSION LINE PERMIT

STATE OF ALABAMA |

COUNTY OF SHELBY |

We, S. B. Williamson and wife Lucile Williamson for and in consideration of the sum of one and no/100 Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to permit other corporations, and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama.

Begin at NW corner of SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 26, Tp. 19 Range 1 West thence south 236 feet to south line of Highway to point of beginning, thence East along said South line of highway 350 feet, thence south 520 feet, thence West parallel with highway 420 feet, thence north 520 feet to south line of highway thence East along highway 70 feet to point of beginning, being in SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 26, Tp 19, Range 1 West in Shelby County, Alabama.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same unto the said Company, its successors and assigns, forever.
