Bullard, an unmarried man for and in consideration of the sum of One and no/100 Dollars (\$1.00) to me in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama:

A part of $NW_{4}^{\frac{1}{4}}$ of $SE_{4}^{\frac{1}{4}}$ of Sect. 24, Township 21, Range 1 W beginning at SE corner of said 40 acres and running west along south boundary of said $NW_{4}^{\frac{1}{4}}$ of $SE_{4}^{\frac{1}{4}}$ 400 yards to old Columbiana-Wilsonville Road (now abandoned as a public road), thence in SE direction along said road 156 yards, thence east 350 yards to east boundary of said $NW_{4}^{\frac{1}{4}}$ of $SE_{4}^{\frac{1}{4}}$, thence east along said boundary to point of beginning.

Also commencing at SE corner of NW₄ of SE₄ of sect. 24, Tp 21, R 1 W and running S 86 degrees 10' W along southern boundary of said SW₄ of SE₄ 1132(to a point where said line intersects the west boundary of the Columbiana-Wilsonville highway r/w to point of beginning, thence in south direction 196' to old Columbiana-Wilsonville road, thence S 1 degree 10' W along said road 125', thence N 86 degrees 10' E 169' to point on W boundary of said highway, thence N 12 degrees E along said highway 128.8' to point of beginning.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.
