STAT OF ALABAMA I

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,...and wife...of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-Way hereinafter described, over and across our said lands in Shelby County, Ala. for a public road; which right-of-way shall be 50 feet in width on southeast side of the center line of said road, as it is now located and staked out by the State Highway Department or as much of our lands as is required to make a 100 foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit:

and as shown by the right-of-way map of Federal Aid project No. 176 A (2), as recorded in the office of the Judge of Probate of Shelby County:

beginning at station 935/00 of said Project, the west property line; thence 93.1 ft. N 48 degrees 40°E; thence 251.9 ft.northeasterly along a 3274.17 ft. radius curve, concave northwesterly to station 938/45, the point of ending at the north property line.

Said strip of land lying in the NET of SWT of Section 17, Tn 24 N, Rn 12 E and containing 0.4 acres, more or less, including area now used as right-of-way.

To have and to hold by Shelby County, or its Assigns, and for and in consideration of the benefit to our property by reason of the construction or improvement or said road, we have hereby release the County aforesaid, and all of its employees and officers, and the State of Alabama, and all of its employees and officers from all consequential damages, present or prospective, to our property, arising out of the construction, improvement, maintenanceor repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged. All agreements covering the moving, relocating and/or changing of the buildings and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department.
