4th. I hereby name and appoint my Sisters Effie and Emma executrix of this my will, without cond, and in case one should die the remaining one shall perform and carry out the work intended for both.

Said last will and testament hereby amended and to which this codicil is filed being written in the hand writing of T. B. Alford, now deceased, and bearing date of the 19th day of September, 1904, and containing four paragraphs and my signature thereto being attested by the said T. B. Alford and T. N. Norris.

ONE. I hereby will and bequeath to my sisters, Effie McAllister and Emma McAllister all of my property, real estate, money and all personal property, wheresoever the same may be located, which I may own or of which I may be possessed, or to which I may be entitled at my death, and the title to the same to vest in my two said sisters, Effie McAllister and Emma McAllister, for and during their natural life only. I do further give, devise and bequeath to the one of my said sisters, Effie McAllister or Emma McAllister, who shall survive the other and entire right and ownership in and to all of my property as set out herein which shall have vested in the other sister by the terms of this will. It being my intention that the survivor of my two sisters named in this paragraph shall automatically succeed to all the rights, privileges, immunities and benefits of both of my said sisters under the terms of this will.

I do hereby give and grant unto my said sisters, Effie McAllister and Emma McAllister, full power and control of all my property set out herein during their lives, such power being vested in the survivor of the two and include the absolute and unconditional right of my said sisters or either of them to sell and convey any or all of the real estate hereby bequeathed and for and at such prive and on such terms and conditions as they may doem nest to do and they and each of them are given full power to invest, handle or expend the proceeds of any such sale made by them in such manner as they may see fit to do and I do hereby give and grant unto my said sisters, or either of them, the same power over my personal property as I have given to them over my real estate, the said power given to my said sisters named herein being given to them both jointly and separately.

And it is my will and desire and I do hereby direct that my said sisters named herein, nor either of them, be required to make any bond as executrix of my estate or to account to any court, or to file in any court any inventory or account of my said property of any class or kind whatsoever controlled or expended by them or either of them.
