Said strip of land lying in the NE4 of SW4 of Section 17, Tn 24 N. Rn 12 E and containing 0.2 acres, more or less, including area now used as right-of-way.

State of Alabama to replace wall in front of house if necessary or changed.

To have and to hold by Shelby County, or its assigns, and for and in consideration of the benefit to our property by reason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees and officers, and the State of Alabama and all of its employees and officers from all consequential damages, present or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged, All agreements covering the moving, relocating and/or changing of the buildings and/or structures located wholly or partially on the above described right of way shall be in writing and approved by the State Highway Department before same shall be void and binding on the said State Highway Department.
