KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, and wife of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a right of wah herein after described, over and across our said lands in Shelby County, Alabama, for a public road; which right of way shall be 40 feet in width on each side of the center line of said road, as it is now located and staked out by the State Highway Department or as much of our lands as is required to make a 80 feet right of way across our lands, said right of way herein conveyed being more particularly described as follows: to-wit:

A strip of land lying on both sides of State roject S-44-D as located and staked out by the Alabama Highway Department.

Said strip of land lying in two parcels; the first beginning at Station 397/44 on centerline of said project and extending in a Southwesternly direction a distance of 1611 feet to Station 413/55.

Second parcel beginning at Station 425/87 on centerline of said project and extending a distance of 1286 feet on each side of centerline to Station 438/73 and from Station 438/73 to Station 462/13.2, a distance of 970.2 feet on the right side or north side of said centerline.

The right of way on this trip of land being now 66 fert inwidth, 33 feet in width on each side of centerline; this deed to extend right of way semen (7) feet on each side making right of way 80 feet in width on the first parcel and 40 feet in width on the north side of the second parcel.

Said strip of land lying in Section 13,& 14, Township 22-S, R 2-W, in Shelby County and containing 1.08 acres more or less.

To have and to hold by Shelby County, or its assigns, and for and in consideration of the benefit to our property by meason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees and officers, and the State of Alabama and all of its employees and officers from all consequential damages, present or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and sknowledged.
