Minutes of stock holders meeting of Larch-Sennett Holding Company, held at 412 North 21st Street in the City of Birmingham, on the 29th day of June, 1938, at 3:00 O'clock P. M.

Present at said meeting were F. E. Butler, Mrs. Lois V. Butler and F. S. Robinson, being the holders and owners of all of the capital stock of said corporation.

At said meeting F. E. Butler presided and Mrs. Lois V. Butler acted as Secretary. The following resolution at said meeting was offered by F. S. Robinson and seconded by Mrs. Lois V. Butler and unanimously adopted.

Whereas, the Larch-Sennett Holding Company has become inactive and not transacting any active business whatsoever, and has no money or holds no liquid assets and is the owner of several parcels of real estate some of which is located in Jefferson County, Alabama, and some in Baldwin County, Alabama, and some in Shelby County, Alabama, and some in Colbert County, Alabama, and;

Whereas, the said Larch-Sennett Holding Company has not for some years had any money or with liquid assets/which to pay the taxes on and against said real estate as the same ould accrue, and all of said real estate has been sold either to the State of Alabama, or to individuals for delinquent taxes, and is now practically lost and of no benefit and of no intrinsic value so far as the said Larch-Sennett Holding Company is interested therein, and is further subject to be entirely lost by purchasers byying the same for the State of Alabama, or other tax title holders; and

Butler, as president of said Larch-Sennett Holding Company be and his is hereby authorized, empowered and directed for and in consideration of the sum of \$1.00 to convey for and in the name of said Larch-Sennett Holding Company to Frank Butler, Jr., all of the right, title, interest and claim of the said Larch-Sennett Holding Company in and to any now and all properties real, personal or mixed, or equities therein/owned, or held by the said Larch-Sennett Holding Company in any place or location whatsoever. It being the purpose of the stock holders of said Larch-Sennett Holding Company to convey the entire corpus of all of the property of said corporation to the said Frank Butler, Jr., for said consideration.

There being no further business before the meeting the same was adjourned.
