Johnson, deceased, and those through whom the said Mrs. Ella Pee les Johnson holds title to the above described lot or tract of land, have been, respectively, in the open, notorious, continuous, peaceable and adverse possession of said lands, claiming them as their own, respectively, against all the world, and regularly exercising acts of ownership over said lands; affiants further say that they have never heard the title of Mrs. Ella Peebles Johnson, or those through whom she holds title to said lands to be questioned in any way.
