

ASSIGNMENT

Whereas, B. F. Roden of Marvel, Alabama is the owner of one thousand five (1005) shares of Common Stock of the Roden Coal Company which the undersigned delivered seven hundred ninety (790) shares to the Miners Savings Bank Pittston, Pa. and two hundred fifteen (215) shares to the Kingston National Bank, Kingston, Pa. as collateral, and

Whereas, said B. F. Roden of Marvel, Alabama is also the owner of one hundred fifty (150) shares Preferred Stock of the Roden Coal Company which the undersigned delivered as collateral to the First National Bank, Pittston, Pa. and

Whereas, the undersigned is at this time unable to deliver said stock belonging to said Roden to him upon demand and desires to furnish security for the return of said stock or to cover its value,

Know all men that I, Charles C. Bowman, residing at 109 William Street, Pittston, Pa. herein called the Assignor, in consideration of one dollar paid by B. F. Roden of Marvel, Alabama, and the aforesaid delivery of one hundred fifty (150) shares Preferred and one thousand five (1005) shares Common Stock of the Roden Coal Company by him to me, hereby assign to the said Assignee all of my right, title and interest in and to a certain deed dated the 30th day of December, 1915 between the Bessemer Coal, Iron & Land Company, an Alabama Corporation, and the Assignor, covering certain coal land in Shelby and Bibb Counties, Ala, which said deed was duly recorded in the Office of the Judge of Probate, Shelby County, Ala. on January 12, 1916 and recorded in deed record 58 pages 329-34, and also recorded in the Office of the Judge of Probate of Bibb County, Ala. on May 2nd, 1916, in volume 18 of deeds on pages 304-309, and also all of my right, title and interest in a certain lease between the Assignor and the Roden Coal Company dated the 8th day of January 1916 and recorded in the Judge of Probate's Office, Bibb County on January 24, 1916, in volume 18 of deeds, pages 155-161, and recorded in the Judge of Probate's Office in Shelby County on February 15, 1916 in deed record 58, page 257-267, together with all moneys, royalties, interest, benefits and advantages whatsoever now or which may hereafter become due by virtue thereof.

This assignment is subject to any indebtedness still due to Law W. Bowman, Pittston, Pa. and respecting which a prior assignment was given him dated August 10, 1933.

To have and to hold the same to the Assignee, his successors, legal representatives and assigns, forever.
