KNOW ALL MEN BY THESE PRESENTS: That in consideration of Two hundred and no/100 dollars and the execution of a purchase money mortgage in the sum of Seven hundred and no/100 dollars, to the undersigned grantor A. Peck, unmarried, do grant, bargain, sell and convey unto the said A.Laverne Todhunter the following described real estate, to-wit:

NW½ lying in Jefferson County Alabama, and except 5 acres in the Northeast corner off the

SE½ of the NW¼, said 5 acres being described as follows: Begin at the Northeast corner of said

40 acre tract; run thence west along the north line thereof 479 feet; thence south and parallel
