Quit Claim deed

KNOW ALL MEN BY THESE PRESENTS:

That we, Burr Harris and wife, Ethel Harris, of said County and State, for and in consideration of the sum of One dollar and other good and valuable considerations, in hand paid to me by Virginia Means, the receipt whereof is hereby acknowledged, do hereby remise, release, quitclaim and convey unto the said Virginia Means, all our right, title, and interest and claim in or to the following described real estate situated in the County of Shelby, State of Alabama, to-wit:

Begin at the northeast corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$, Section 3, Township 22, South, Range 4 West, thence run West along said section line a distance of 310 feet; thence run in a southwesterly direction 410 feet to the north line of the Columbiana-Tuscaloosa public road; thence run in a southeasterly direction along said road a distance of 200 feet; thence run north 300 feet; thence run East 210 feet to the East line of the above said section; thence run north along said section line 285 feet to the point of beginning, situated in Shelby County, Alabama. Containing 2 $\frac{1}{2}$ acres, more or less.

The mineral rights hereto are owned by the Alabama Mineral Land Company and are not intended to be conveyed by this deed.

This deed is executed to correct the description contained in that certain deed executed on May 27th, 1937, signed by Burr Harris and wife, Ethel Harris, in which deed William Harris was the grantee. Said deed being recorded in deed book 109, page 253, in the Probate Office of Shelby County Alabama,

To have and to hold the same unto the said Virginia Means and unto his heirs and assigns forever.
